Resolution Financing Terms for the Bond Anticipation to authorize the Supervisor to approve the Note in the amount of \$1,000,000. Councilwoman Grant made a motion to authorize Supervisor Haywood to approve Financing terms of the Bond Anticipation Note for Water Improvement Benefit Area #1 in the amount of \$1,000,000.00; seconded by Councilman Anderson and carried by a vote 5-0.

2020 Budget with all the budget cuts due to loss of County sales tax \$235,000 will be taken out of the contingency.

BILLS: The bills were presented for audit and totaled General A Fund \$5,031.24; General B Fund \$4,658.03; Highway DB \$21,056.15; Water District \$20,364.75; PA-A \$2818.06 and PA-DB \$4,617.64. Councilman Starowitz made a motion to pay the July bills; seconded by Councilwoman Grant and it carried by a vote 5-0.

Distribution Payments - July 2020 update

Due to Novel Coronavirus (Covid-19), Genesee County Leadership has hosted a Saturday morning conference call where the Chief Elected of each municipality is invited. The Saturday morning conference calls first began on March 14, 2020, due to the State of Emergency Orders with County, City, Towns and Villages. The Public Health Director and Emergency Management Director of Genesee County have reported and responded on the weekly call with our partners.

Chair Stein stated on March 28, 2020 that distribution payments to Towns and Villages are paused for now until further notice due to the drop in county revenue and cuts in reimbursement of state mandates. Notice was provided to alert municipal leaders to make adjustments in spending plans, pause projects and wait with the County to seek clarity on financial impact to each level of government due to NY on Pause.

Due to a decrease in both County revenue and State reimbursements, Genesee County Legislators voted in May 2020 to revoke the authority of the County Treasurer to automatically distribute payments according to the schedule created in 2018. The Intent to distribute payments again is clearly stated.

Distribution payments have been made to towns and villages on April 24, 2020, prior to Covid-19 – NY on Pause.

To insure all possible financial impact facts are known by County Administration and Legislature prior to any further distribution payments to towns and villages four points of knowledge must be gained.

- 1. Federal Stimulus Covid 4 payment
- 2. NYS Governor Unilateral Budget Adjustment April 30
- 3. NYS Governor Unilateral Budget Adjustment June 30
- 4. Second Quarter Revenue Receipts

Second quarter sales tax loss is affirmed. State Aid reductions are starting to trickle down, but the State has largely remained silent on their plans for State Aid cuts. So far reductions of 20% to CHIPS funding, VLT revenue and Mental Health programming have been announced. These losses must be made up by County in the current budget.

State mandated services are the sole responsibility of Genesee County. Further mandated service reimbursement reduction by the State is anticipated. The full extent is not yet known. The County is awaiting information on COVID 4 Stimulus Federal payments directed to the County, Towns and Villages. Additional clarity on Stimulus payments anticipated in August 2020.

NYS has communicated that budget adjustments will be made once COVID 4 Stimulus Federal Payments are known.

County Legislators have determined \$1.1 million is to be distributed to Towns and Villages on July 23, 2020. Intent to distribute as stated in May 2020, continues our commitment with local governments.

Further distributions will be made as financial facts are known. County Legislators fully acknowledge our hope to recover from this unprecedented pandemic with the least fiscal harm to all of local governments and ask for continued patience and flexibility with each other — together we are stronger.
