# RESOLUTION#21-2021 INCREASING THE MAXIMUM AMOUNT TO BE EXPENDED FOR THE CONSTRUCTION

# OF WATER IMPROVEMENT BENEFIT AREA NO. 1 PURSUANT TO SECTION 209-h OF TOWN LAW

In the Matter of the Increase in Maximum Amount to Be Expended for the Facilities of Water Improvement Benefit Area No. 1 in the Town of Bergen, in the County of Genesee, in the State of New York, Pursuant to 209-h of the Town Law

WHEREAS, the Town Board of the Town of Bergen (the "Town Board") previously adopted on February 11, 2020 an Order establishing Water Improvement Benefit Area No. 1 (the "District") in the Town of Bergen (the "Town") which was filed in the Genesee County Clerk's Office on February 12, 2020 as Instrument # MR2020-93 together with a Corrected Order recorded in the Genesee County Clerk's Office on March 5, 2021 as Instrument # MR2021-126 (collectively the "Order"), and

WHEREAS, the Order called for the construction of a water system pursuant to a map, plan and report prepared by the Town's Engineer, MRB Group ("MRB") last dated May 17, 2019 and on file in the Office of the Town Clerk of the Town of Bergen (the "Project"), and

WHEREAS, the Order established the sum of \$8,958,000.00, partially offset by an United States Department of Agriculture Grant, as the maximum amount to be expended for the Project. Said amount to be borne by the properties within the District on a benefit basis.

WHEREAS, the Town has determined the maximum cost of the Project as described in the Order has increased, and

WHEREAS, the scope of the Project including the Project Area, Project Design and boundaries of the District described in the Order have not changed, and

WHEREAS, the Town Board having previously declared itself Lead Agent pursuant to the State Environment Quality Review Act ("SEQR") and having previously reviewed and accepted a long form environmental assessment of the Project prepared by LaBella Associates, and declared that based upon a review of the assessment, the Project will not have a significant adverse impact on the environment and issued a Negative Declaration under SEQR for the Project, and

WHEREAS, the maximum amount to be expended for the Project has increased to \$10,485,000.00 to be partially, offset by additional grant monies from the United States Department of Agriculture, and

WHEREAS, after MRB duly filed a revised map, plan and report in the office of the Town Clerk of the Town describing the increase in the maximum amount proposed to be expended for the Project, the cost to a typical user, the Town Board did conduct a public hearing on July 13, 2021 regarding the proposed increase to hear all persons interested in the subject thereof concerning the same, and

WHEREAS, copies of the Notice of Public Hearing were duly published and posted according to law, and the Town Board did, at the time and place specified in said Notice, duly meet and consider said proposal and hear all persons interested in the subject thereof, who appeared at such time and place, concerning the same, and

WHEREAS, the evidence offered at such time and place requires that the Town Board make the determinations hereafter made;

NOW, THEREFORE, BE IT RESOLVED, by the Town Board of the Town of Bergen, in the County of Genesee, that it be and hereby is determined as follows:

It is in the public interest to approve an increase in the maximum amount to be expended for the Facilities of Water Improvement Benefit Area No. 1 in the Town of Bergen as hereinafter described; and be it

FURTHER RESOLVED, that the maximum amount to be expended for the proposed improvements, including costs of the physical improvements, construction costs, legal fees, and other expenses shall be the sum of \$10,485,000.00 to be partially offset by a United States Department of Agriculture grant of \$3,635,000.00, said amount to be borne by the properties within the District on a benefits basis; and be it

FURTHER RESOLVED, that the total annual cost for a typical user of the District is now estimated to be \$1,034.44 (including debt service and water usage cost); and be it

FURTHER RESOLVED, that the increase in the maximum amount to be expended for the Project will be subject to the approval of the Office of the State Comptroller; and be it

FURTHER RESOLVED, that the proposed method to be employed for financing such improvement based on the increased cost is projected as follows:

The cost of the water district construction would be paid through a benefit based assessment against the properties within the proposed water district. It is anticipated that the project cost will be financed by the issuance of one or more bonds of the Town, to be paid over 38 years at an estimated interest rate of 2.5% per annum for the original \$5,900,000.00 loan and an estimated interest rate of 1.375% per annum for an additional \$950,000.00 loan; and be it

FURTHER RESOLVED, that the total first year cost for the typical user, including one-time hookup fees for the proposed Water Improvement Benefit Area No. 1 is now estimated to be \$2,674.44 broken down as follows:

Installation of water Service \$1,200.00; Internal Plumbing Charges \$200.00; Repayment of Bonds \$643.04; Water Meter and Account Fee \$240.00; Repair Reserve \$20.00; and Purchase of Water (60,000 gallons/year) \$371.40

FURTHER RESOLVED, that the Resolution increasing the maximum cost of the Project is subject to a permissive referendum in accordance with Section 209-h and Article 7 of Town Law.

<u>Hire investigator to investigate claim</u> Councilman Anderson made a motion to hire Richard Rosenbloom, ESQ to investigate the claim filed for \$2,600; seconded by Councilwoman Sapienza and carried by a vote 5-0.

<u>Library funds Transfer</u> Councilman Anderson made a motion to transfer the remaining funds budgeted for 2021 to the Library of \$33,040.00; seconded by Councilwoman Grant and carried by a vote 5-0.

BILLS: The bills were presented for audit and totaled General A Fund \$13,804.12; General B Fund \$2,240.21; Highway DA \$6,229.52; Highway DB \$4,867.02; HH (Water District) \$11,646.30; PA-A \$3,555.67; PA-DA \$2,321.82 and PA-DB \$2,515.30. Councilman Grant made a motion to pay the July bills; seconded by Councilman Starowitz and it carried by a vote -0.
