From the Desk of Town Supervisor, Ernie Haywood....

I reported in the last newsletter that the Town of Bergen received NYSERDA's Clean Energy Communities Designation and was subsequently awarded a total of \$15,000 to conduct energy audits on the Town's buildings to determine ways to save on our energy costs. Additionally, we are \$22,431 on a \$2.6 million budget. pursuing the installation of electric charging stations at Robins Brook Park.

Future improvements to Robins Brook Park depend heavily on the availability of utilities, namely electric and water. We are in the process of installing both utilities at the park which will not only allow the installation of the EV charging stations, but also down the road, public restrooms. We hope to have both the energy study and electric utility installation completed at year's end or soon afterwards.

We will continue to pursue grants for improvements at the park. We also are awaiting a decision on a grant application to improve Cyber Security for town information technology systems.

The Bergen Town Board adopted the 2025 Budget at our November 12 meeting. For the first time in many years, we were able to keep the budget below the New York State Tax Cap. The tax cap allowed us to raise taxes by We only raised taxes by \$21,405 (\$1,026 less than allowed). The areas of tax levy increase were the highway fund (\$19,639) and Fire District (\$10,295). These increases were partially offset by reductions in the general fund tax levy and WIBA1 levy. The WIBA1 EDU (the amount property owners will see on their January 2025 town tax bill) fell from \$590.30 to \$580.13 primarily due to new users.

We reduced the use of fund balance by \$54,607 (or 2.95%) as certain non-property tax revenue streams remain stagnant or have dropped. Between some new growth and our assessor updating the rolls, our tax base grew by \$23,804,464 or 11.25%. This increase, coupled by a very small

tax levy increase, resulted in a tax rate reduction from the 2024 rate of \$2.8003 to \$2.5743 in 2025. This \$.226 rate drop means the impact of the assessment increase will only be about \$2.46% for the average property owner which is close to the inflation rate.

Overall, I believe we adopted a fiscally responsible budget with a minimal impact to property tax payers while preserving all services for our residents.

Construction has begun on both the OXBO Facility and Dollar General in the Appletree Industrial Park. Thank you to the planning board for its work reviewing these projects to make sure that all state and local requirements are met as we welcome these new facilities to our community.

The Town Board has scheduled its final meeting of the year for December 30 and we will hold our 2025 Organizational Meeting on January 14, 2025. We wish everyone a safe, healthy and happy holiday season.

Members past and present enjoyed to a refreshments


Members past and present enjoyed tea, refreshments and conversation. They shared many memories of past meeting and members.

Partial Property Tax Exemptions/ Credits:

STAR *Exemption* (Only applies to your primary residence purchased prior to March 1st, 2015 & reduces School tax bill only).

Basic Star Exemption: Primary residence, any age owner, Household Adjusted Gross Income \$250,000 or less.

Enhanced Star Exemption: Primary residence, one resident owner or spouse 65 or older, Household **Adjusted**Gross Income of \$107,300 or less (taxable IRA not included). Must apply by March 1st any given year with the Assessor's Office.

STAR *Credit* (Only applies to your primary residence purchased after March 1st, 2015 applies to School tax only...issued as a check from NYS Taxation vs a reduced School tax bill).

Basic same as above

Enhanced same as above For both STAR Credits...you must apply directly with NYS Taxation by July 1st any given year: https://www.tax.ny.gov/star/

*You can only receive one: The Star Exemption or the STAR Credit.

Senior/Aged Exemption (This partial exemption can apply to both the School tax billing and the Town/County tax billing in addition to the Enhanced Star, based on a sliding scale).

Must be 65 or older, with Household **Gross** Income of \$32,200 or less (taxable IRA not included). Apply any given year by March 1st with the Assessor's Office.

Limited Income Disability Exemption

(This partial exemption applies to the County tax billing only).

Any age, Household Gross Income of \$24,900 or less, must have NYS disability award letter. (If over 65, you can only receive Senior **or** Limited Income).

From the Desk of County Legislator Christian Yunker.....

The Managers office and the Legislature has been very busy working on the 2025 Genesee County Budget. The Budget was built in an efficient and responsible manner while making to fill the posts at the County Jail. key investments which that will help deliver better service to residents of the County. The Budget stays under the NYS tax cap, while covering the many expensive State mandates of which we no control over (makes of 95% of the property tax levied estimated at over \$32.1 million for 2025). The Managers office and Legislature decisions had been influenced by the County embarking on two of the largest capital infrastructure projects in its history with a new County jail that we completed with a price tag of \$70 million and continued progress on the County wide water system with a current projected price tag of \$150 million.

The 2025 all funds budget totals over \$189.2 million which is \$5.7 million more than the 2024 adopted General fund budget. Major increases impacting this are \$4.4 million increase in salaries and related costs, \$1.5 million increase in NYS retirement system costs, \$1.9 million increase preschool supportive health services program, increases in court ordered competency evaluation costs, health care costs increases among many other inflationary pressures that face all of us. Personnel related costs are significant drivers in a service and public safety related business that we are in. We are one of the largest

employers in the County. A large part of this related increase is the addition of 10 new correction officer positions needed

The County continues to make key investments in water infrastructure and the regular addition to our bridge and culvert replacement fund and as well as many public safety investments. Among those is our effort to stabilize and continue to contribute to Mercy Flight and LeRoy Ambulance.

For the first time since 2000, our sales tax revenue has declined year over year falling behind our 2024 budgeted revenue. To combat this decline in sales tax revenue, while increases persist in most other costs, we have decided to utilize \$2.5 million of our fund balance, \$639K of our medical reserve balance, raise the tax levy but not to our allowance. This is the 5th consecutive year staying under the cap and over the past 5 budgets only have an 8.3% levy increase which would be well below the cost of inflation for that time period. Despite all these costs increases and investments we were able to bring the tax rate down from \$8.08/1000 to \$7.57/1000 or 6.3% in the recommended budget. We believe this budget is responsible provides key investments for our future that benefits all the residents of the County. 
